Linda asked all to consider how many of these actions did we actually do/accomplish? Linda asks folks to share what they've achieved in terms of these goals

- 1) Capacity Building
- a. Increasing membership→We've reached out to 7-8 orgs
- b. Policy handbook→ partner press releases, logo, etc. has been posted in partner portal
- c. Press release "team" put together three releases: One in March for NYS 575 release, one for EAB awareness week in May and lastly for ISAW
- d. Website committee held visioning meeting → progress on maps and geo-data section
- e. Five other orgs sent out press releases for EAB awareness, ISAW

- 2) Conservation Targets
- a. Hudsonia looking at tidal estuaries and the impact of I.S. on rare species → trying out field methods with more field work planned for the summer
- b. North American Landscape Cooperative developing conservation plan for Hudson Valley Region →
   John Mickelson has been in touch and we might collaborate
- c. NYNJ Invasive Strike Force worked surveyed Black Rock Forest→ possible Invasive Species prevention zone, as there is virtually no I.S. except stilt grass. They also propose ISPZs for Storm King State Park and Schunemunk State Park in Orange Cty.
  - 3) Strategic IS Management
- a. NYNJTC Invasive Strike Force Crew has done:
  - i. ED treatment and removals of Siebold viburnum, wintercreeper, hardy kiwi and several other species at locations throughout Westchester, Dutchess and Rockland→ they've had success with controlling scotch broom populations in Harriman
  - ii. Surveying for I.S. in Northern Dutchess County and recorded in iMap.
- b. Other NYNJ Trail conference volunteers have done surveying, including 22 volunteers east of the Hudson and 13 west of the Hudson
- c. Linda worked with Adirondack PRISM and a few other partners on 2 EE recommendations for licensed professionals. This included for Hardy Kiwi, Barberry, Burning Bush, Porcelain Berry and others → This information will be posted on the website via a link to the PIMS website (<a href="http://pims.psur.cornell.edu/">http://pims.psur.cornell.edu/</a>)
  - \*Eric Kiviat put in a request to control *Aralia elata* where it is encroaching on the prickly pear population(s) on Iona Island.
  - 4) Education and Outreach

Blockbuster survey- almost 250 new occurrences of invasives reported; no focal list surveys

Q: Are blocks prioritized? → Not this year but definitely next year

Suggestion: Let's focus on highly probable areas for focus next year, to seek out emerging invasives and on road-side areas in agricultural zones.

Q: Are we having access problems with private properties? 

Permitting has been tricky; maybe for next year if we plan ahead of time

- \*John Mickelson wanted to emphasize that we have topos maps for all PRISM Blockbuster survey blocks.
- a. Volunteers with Clearwater have been surveying for under-reported species, "highly invasive," and "highly probable" all over the region (particularly in high priority sites)
- b. DEP has:

- i. Released biocontrols (weevils) for mile-a-minute at a tornado site and removed *Aralia elata* in Valhalla at Kensico reservoir to prep for tree planting.
  - ii. Surveyed 2 blocks in town of Kent for Blockbuster survey
- iii. Surveyed for water chestnut @ Muscoot reservoir -> they're trying to get mechanical harvester, probably for next year.
  - iv. Establishing a volunteer program

#### c NYBG is:

- i. working with NYS parks on a DEC grant to survey for *Corydalis incisa* in region of Bronx River; plant is now present in Washington DC and Philadelphia area → discovered as a result of sharing information, underscoring importance of doing so
  - ii. Helping to Manage water lettuce population in Central Park Pond
- d. Vassar College is working with USDA-APHIS on EAB parasitoid releases on campus and at Cary Institute
- e. Trillium is working on various removal projects, including one with Scenic Hudson on both public and private land in the Esopus area
- f. Sawmill River Audubon working on surveys with Con-Ed and Hudson National Golf Course
- g. NYC Parks is:
- i. Releasing biocontrols for Mile-A-Minute at Pelham Bay Park
- ii. Other removals at Pelham Bay and other Bronx parks
- iii. Removals of Japanese knotweed along Bronx river

Q: How is the mile-a-minute weevil working in terms of control?--> General consensus seems to be that it is effective in small areas; it can get established easily and move up to 10 miles

- h. West point is surveying water chestnut and will work with boyscouts and girlscouts on removals
- i. CCE Dutchess and Rockland have IS sections on websites
- j. CCE Orange held Greenhouse school for nurseries/landscapers; Chris Logue from Ag. & Markets discussed new regulations
- k. CCE Putnam and Linda Rohleder did training on invasive ID with Kent Highway Dept.
- I. CCE Rockland did presentation for county
- m. Nordica Holochuck with Sea Grant educates boatowners up and down Hudson
- n. Clearwater held trainings for I.D. and survey protocol + boat steward program
- o. NY state has hired an aquatics educator Katherine McGlynn→ has background with LHPRISM
- -ACTION ITEM: Put together a wallet card with the number for Dept. of Ag & Markets to report
- 5) Mitigation of Pathways
- a. Clearwater has 2 paid boat stewards: one at Norrie Point and the other at Croton Boat Launch  $\rightarrow$  all boats checked except those at rental station
- b. DEC and NYC Parks held 7 EAB workshops around the city
- c. Society of Hudson Valley arborists → EAB quarantine update at last meeting
- 6) Information Exchange
- a. –Basic info. + BMPs on species in Information Exchange area of website

### Moving forward on the Action Plan

Q: Where are the gaps in the action plan?

- -Capacity Building → recruiting more partners, training more volunteers, working on the website, feeding three research needs
- -Strategic planning → communication plan, rapid response for Invasive Species
- -BMPs→ we have a rudimentary structure with 10 completed BMPs; needs more work
- -Mitigation of Pathways → Getting website organized and well-designed → funds next year for web designer to help out

NOTE: The state has hired an education coordinator who can manage the "bookshelf" of resources and information

ACTION ITEM: Share information with whole group on protocol for posting links of partners on PRISM website and vice-versa.

- -Blockbuster Survey → Let's definitely do it again next year.
- -New Partner Plan → What areas are not represented? Rockland? Dutchess?
- -Partners Handbook→ need someone to take on this project; will help clarify what it means to be a partner in PRISM for those who are new or considering it.
- Q: Could we hold "themed" meetings on particular topics like aquatics so that partners can pick and choose the meetings that they want to attend?  $\rightarrow$  It's tricky to find the time but perhaps we could have special interest sections when we get a larger critical mass (currently ~40 partners)
